The Governor, Himachal Pradesh in exercise of the powers conferred under Section 16 of the National Food Security Act, 2013 read with Rule 8 of Chapter-IV of the Himachal Pradesh Food Security Rules, 2019, is pleased to order that all the Deputy Commissioners (DC) or Additional Deputy Commissioners(ADC)/Additional District Magistrates (ADM)/Resident Commissioner(R.C)/Sub Divisional Magistrate(SDM) shall function as ex-officio District Grievance Redressal Officer for expeditious and effective redressal of grievances of the aggrieved persons in matters relating to distribution of entitled foodgrains or meals under chapter II, and to enforce the entitlements under the Act in the following manner:-
